PAYMENT TERMS - A 1.5% monthly finance charge will be added to all overdue accounts.

INSURANCE COVERAGE - Rockport Marine will not be held responsible for loss due to fire, theft, vandalism, or the elements. Boats in our care are insured against loss only if that loss is found to have been caused by our negligence. We require that all storage customers carry liability insurance on their hulls during the off-season months.

Storage Contracts: Boat storage requires a signed storage contract.

Payments: Invoices are due upon reciept. A 1.5% monthly finance charge will be added to all accounts 30 days past due. For non-storage customers payment must be made before the vessel or fabricated part leaves the yard.

Payment for Hydraulic Trailer Transportation: is due at the time service is rendered.

Outside Labor: Rockport Marine is not a 'do-it-yourself' yard. To a negotiable extent owners and crew may perform their own work outdoors or on the dock. The yard's tools and equipment are only available to RM employees. RM reserves the right to charge for clean up as a result of owner/crew labor.

Subcontractors: No work may be performed by outside contractors unless approved by Rockport Marine. Subcontractors must provide a certificate of insurance to the Rockport Marine Office and alert the office as to their schedule. We reserve the right to charge a subcontractor fee.

Parking: On arrangement with Rockport Marine vehicles may be left in our lot at the owner's risk. Keys must be left available to the yard crew with the understanding that the vehicle may need to be moved.

Dockage Cancellation: For cancelation of a dock reservation within 48 hours of intended arrival 1 night dockage will be charged.

Transportation Territory: Rockport Marine offers boat/spar transport within a 35 mile radius.
